## Celebrate 33 Years Together

## **FULL OFFICIAL ONLINE CONTEST RULES & REGULATIONS**

- 1. **How to Enter: No Purchase Necessary.** Commencing at 8:00 a.m. PST on October 12, 2022, participants can enter the *Celebrate 33!* online contest by completing the Official Entry Form available online at <a href="https://park.ca/egbc-giveaway/">https://park.ca/egbc-giveaway/</a>, with their name and e-mail address.
- 2. **Eligibility:** The Contest is open to legal residents of Canada who have reached the age of majority in British Columbia, and according to the present rules: 1) are registrants of Engineers and Geoscientists BC, 2) are residents of the province of British Columbia, 3) except employees, representatives and agents of the Sponsor, and, its advertising and promotion agency, and members of the immediate families of, or persons domiciled with, any of the above. - 3. **Entry Limits:** For purposes of this Contest, each person or household is restricted to one entry per EGBC registrant residing in the province of British Columbia. Any excess entry forms will be deleted for purposes of the draw.
- 4. **Prize:** The prizes available to be won are six (6) Gift Cards each valued at \$100.

Draw: On October 14, 2022, commencing at approximately 10:00am (PST) in Burnaby, BC, six (6) entrants will be randomly selected as potential Prize Winners, from among all eligible entries received on or before the Contest Closing Date. Odds of being selected depend on the total number of eligible entries received during the Contest Period. Selected Entrants will be contacted by email within ten (10) days of the draw date. If a Selected Entrant cannot be contacted by email within ten (10) days of the draw date, said Selected Entrant will be disqualified and another Entrant will be randomly selected until such time as contact is made by email with a qualified Entrant. The Sponsor will not be responsible for failed attempts to contact a Selected Entrant.
